HARVEST GOLD QUARTER HORSE FUTURITY
STALLION CONTRACT

THIS CONTRACT IS BETWEEN THE **SASKATCHEWAN QUARTER HORSE ASSOCIATION/HARVEST GOLD FUTURITY**, AND THE STALLION OWNER OR AGENT.

1. Futurity class eligibility is limited to Harvest Gold Futurity enrolled stallions and their get.
2. Stallions nominated will be sold to the highest bidder by mailed-in sealed bid up to **MARCH 1ST**. Bids must be at least 1/2 of the service fee or \$250.00, whichever is greater. Cheques may be dated **March 1st**. In case of a tie, bid with earliest postmark will be accepted. After **March 1st** services may be bought for 1/2 listed service fee or \$250.00, whichever is greater.
3. ****FOR FUTURITY PURPOSES, STALLION SERVICE FEE AND BOOKING FEE WILL CONSTITUTE THE STUD FEE.**
4. Purchaser of stallion service (mare owner) may enter resulting foal in weanling futurity class free.
5. Stallion Nominator receives one **FREE** entry to be used the year stallion is nominated and sold. Entry must be used by stallion nominator only.
6. All contractual agreements, guarantees, mare care, chute fee, veterinary costs, and other expenses are solely between service purchaser and stallion owner.
7. Stallions may represent themselves but must be at least 2 years old.
8. Any get sired by a gelded, sold, or withdrawn stallion may pay a one-time nomination fee of \$150.00 to be eligible for futurity. Get of a deceased stallion may show in futurity without paying a nomination fee as long as get is the result of any paid up year of the deceased stallion. Nomination fee & current copy of registration papers must be on file with SQHA.
9. If by July 1st stallion service has not been purchased, owner must submit the nomination fee to SQHA by July 15th. ****AFTER JULY 15TH, ALL STUD FEES ARE PAYABLE AT FULL PRICE AND WILL BE ACCEPTED UP UNTIL THE NIGHT PRIOR TO THE FUTURITY.**
10. A current copy of stallion's registration papers must be sent to the HARVEST GOLD FUTURITY chairman; if not, stallion will not be enrolled and get will not be eligible to show.
11. The SQHA reserves the right to all final decisions regarding any disputes.
